CERTIFICATE IN WORKING THERAPEUTICALLY WITH CHILDREN AND YOUNG PEOPLE AGED 4 TO 18 YEARS PRESENTING WITH DOMESTIC ABUSE AND WIDER LOSS

This is an intensive Bridging Course to develop the competence of qualified adult counsellors to work safely with children and young people aged 4+ presenting with Domestic Abuse and wider loss

- For qualified adult counsellors wishing to gain relevant training and experience, within a BACP accredited service, for supporting children and young people aged 4 to 18 years presenting with Domestic Abuse and wider loss using a therapeutic approach
- Aligned to the BACP Core Competencies for Working with Children and Young People and the BACP Ethical Framework for supporting children and young people aged 4 to 18 years
- All students will be subject to enhanced DBS checks and reference checks following interview process.
- 35 guided learning hours delivered intensively over 5 days, 9am to 5pm, 12th to 16th September 2022 at Warwickshire County Council premises in Warwick
- Following training, students are required to complete a minimum of 100 hours of salaried placement with Listening Ear working with children and young people.
- Placement will be with Listening Ear and, dependent on referral rates, will commence as soon as possible on completion of the taught element of this Bridging Course.
- Placements will be with children and young people in schools or other appropriate venues such as Refuge.
- Some placement hours could be required after school (until 8pm) in place of school-based hours.
- Adults may be seen in safe accommodation or other safe community settings or may express a preference for remote support (telephone or video)
- Additional peer-development groups and individual case management meetings will be organised and are required as part of the placement.
- Certificates will be issued to all students on completion of study and 100 client-facing hours

1.1 Eligibility:

- As a minimum, applicants must previously have achieved a Diploma in Counselling (Level 4) on an adult counselling focussed course. We will consider applications from current Counselling Students who are working towards their 100 hours of supervised, clinical, placement hours with adults. If applying as a current Student Counsellor, you should have completed your course of study already.

1.3 Course Dates:

- Intensive classroom-based study 12th to 16th September 2022 9am to 5pm to be held at Warwickshire County Council premises in Warwick.
- Students must attend all course dates
- Placement hours will commence immediately afterwards and must be completed 2 days per week (dependent on rate of referrals initially)

1.4 Fees:

- FREE training as part of salaried role within Listening Ear

1.4.1 Salaried Training:

The salary for the training and placement hours will be NJC Scale 6 SCP 18 to SO 1 SCP 25 £25,419 to £30,095 (dependent on qualifications and experience in line with LE's pay structure) pro rata based on 35 hours per week. Employees will be paid to deliver:

- 50 minute appointments in schools or other safe locations, therefore you will require access to transport.
- Completion of client management database records (training in system provided) and associated admin
- Travel between schools (as much as possible, we'll try to group appointments together)
- Dealing with risks and incidents (training in CP/Safeguarding and Risk will be provided as part of this course)
- Attendance at a weekly peer-support group
- Attendance at monthly clinical supervision

If you have a clinical supervisor from our approved supervisor list, we can cover the costs of your supervision for the months that you attend placement with Listening Ear. So long as your current supervisor has current experience of working therapeutically with children and young people, they can apply to be accepted onto our approved supervisor register.

In relation to salaried training and placement opportunities, recipients will be required to sign a training form declaring that:

- You commit to attending all training days with Listening Ear
- You commit to completing 100 hours (minimum) placement counselling CYP within Listening Ear
- You are liable to reimburse Listening Ear for any costs incurred should either of the above conditions not be met

These salaried FREE training opportunities aim to address a shortage in the suitably qualified and experienced CYP Counsellors. Therefore, applicants evidencing (through their personal statement on their application form and at interview) a real commitment to working towards being employed as a CYP Counsellor in future, will be prioritised.

At the end of training, and the completion of 100 hours placement hours, Listening Ear will provide you with a Certificate.

1.5 Locations

- Training – Warwickshire County Council, Warwick
- Counselling – we plan to recruit up to 8 counsellors across Warwickshire who between them, can deliver counselling across the whole geographic footprint of the county
